Section 1 - That the Mayor, or the Chief Information Officer as the Mayor's designee, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute Amendment No. 2 to the Riskmaster Accelerator AWS Software as a Service (SaaS) Access Agreement with Computer Sciences Corporation, which is attached hereto and incorporated herein by reference, extending the term of Work Order No. 8 for thirty-six (36) months, from October 1, 2025 to September 30, 2028, at a cost estimated not to exceed \$60,039.30 annually, and the Mayor or the Chief Information Officer as the Mayor's designee be and hereby is further authorized to execute any other documents, including future renewals, necessary for the operation, support, or maintenance of same, all subject to the appropriation of sufficient funds in future fiscal years.

Section 2 - That an amount, not to exceed the sum of \$60,039.30, be and hereby is approved

for payment to Computer Sciences Corporation, from the following accounts in the following amounts: #1101 - 202505 - 71307 (\$51,033.41), #1115 - 202505 - 71307 (\$4,202.75), #4002 - 202505 - 71307 (\$3,001.97), and #4051 - 202505 - 71307 (\$1,801.18), pursuant to the terms of the Agreement.

Section 3 - That this Resolution shall become effective on the date of its passage.
