Section 2 - That an amount, not to exceed the sum stated, be and hereby is approved for payment or transfer to LFUCG Division Of Traffic Engineering (\$30,000.00); LFUCG Division Of Environmental Services (\$15,000.00); LFUCG Division Of Environmental Services (\$632.00); Garden Meadows Homeowners Association, Inc. (\$1,500.00); Voices Of Hope- Lexington, Inc. (\$1,381.96); The Hope Center, Inc. (\$850.00); LFUCG Division Of Traffic Engineering (\$9,000.00); LFUCG Division Of Parks And Recreation (\$30,000.00); and LFUCG Division Of Environmental Services (\$2,574.00), from account #1105-121002-91715, from various Council Districts, pursuant to the terms of the Agreements.
