Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be

and hereby is authorized to execute a First Amendment to Purchase of Service Agreements, which are attached hereto and incorporated herein by reference, with Foodchain, Inc.; Glean Kentucky; God's Pantry Food Bank, Inc.; Greenhouse17; Lexington Gay Services Organization d/b/a Lexington Pride Center; Moveable Feast Lexington, Inc.; and The Nathaniel Mission, authorizing additional funding for services provided to the public in FY2026 pursuant to RFP #20-2024 (Food Insecurity and Nutritional Access).

Section 2 - That an amount not to exceed the sum of \$208,025.00, be and hereby is approved for payment to the following Grantee agencies in the following amounts from the following accounts: Foodchain, Inc. (\$24,184.00) from account #1101-900361-0001- 71101; Glean Kentucky (\$4,000.00) from account #1101-900350-0001-71101; God's Pantry Food Bank, Inc. (\$108,480.00) from account #1101-900323-0001-71101; Greenhouse17 (\$10,000.00) from account #1101-900304-0001-71101; Lexington Gay Services Organization d/b/a Lexington Pride Center (\$15,561.00) from account #1101-900376-0001-71101; Moveable Feast Lexington, Inc. (\$23,000.00) from account #1101-900324-0001-71101; and The Nathaniel Mission (\$22,800.00) from account #1101-900374-0001-71101, pursuant to the terms of the respective First Amendment to Purchase of Service Agreement.

Section 3 - That this Resolution shall become effective on the date of its passage.
