Section 2 - That amounts, not to exceed the sums stated, be and hereby are approved for payment to Common Good Community Development, Corp. (\$2,000.00); The Living Arts and Science Center. Inc. (\$1,000.00); Sayre Christian Village Nursing Home, Inc. (\$3,483.65); LFUCG Division of Parks and Recreation (\$5,000.00); Keep Lexington Beautiful, Inc (\$5,000.00); Black Soil Charitable Fund, Inc. (\$5,000.00); and LFUCG - Complete Streets (\$50,000.00), from account #1101-121002-71214, from various Council Districts, pursuant to the terms of the agreements.

Section 3 - That this Resolution shall become effective on the date of its passage.
