A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to execute and submit the 2018 Consolidated Plan/Grant Application to the United States Dept. of Housing and Urban Development (HUD), to provide any additional information requested in connection with this Grant Application, and to accept the Grant if the application is approved, which Grant funds are in the amount of \$3,805,246 Federal funds, are for FY 2019 Community Development Block Grant (CDBG) Program (\$2,303,582), HOME Program (\$1,314,292), and Emergency Solutions Grant (ESG) program (\$187,372), the acceptance of which obligates the Urban County Government for the expenditure of \$318,380 from various funding sources as a local cash match and \$154,708 in-kind match; authorizing the Mayor to execute Agreements for the approved plan and authorizing the Mayor to transfer unencumbered funds within the Grant Budget. Authorization to submit the 2018 Consolidated Plan, accept awards of Federal funds for Community Development Block Grant Program in the amount of \$2,303,582, HOME Investment Partnerships Program in the amount of \$1,314,292, and Emergency Solutions Grants Program in the amount of \$187,372, from the U.S. Department of Housing and Urban Development for FY 2018, and to authorize execution of Agreements with sub recipients in accordance with approved plan subject to final Federal allocation amounts for Fiscal Year 2019. BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute and submit the 2018 Consolidated Plan/Grant Application, which is attached hereto and incorporated herein by reference, to the United States Department of Housing and Urban Development (HUD), to provide any additional information requested in connection with this Grant Application, and to accept this Grant if the application is approved, which Grant funds are in the amount of \$3,805,246.00 Federal funds, are for FY 2019 Community Development Block Grant (CDBG) Program (\$2,303,582.00), HOME Program (\$1,314,292.00), and Emergency Solutions Grant (ESG) Program (\$187,372.00), the acceptance of which obligates the Urban County Government for the expenditure of \$318,380.00 from various funding sources as a local cash match and \$154,708.00 in-kind match.

Section 3 - That subject to the provisions of Ordinance No. 22-79, the Mayor is hereby authorized, in his discretion as Chief Executive Officer of the Urban County Government, to transfer the unencumbered balance of any operating or capital account appropriation to another operating or capital account appropriation within the Grant Budget established herein.

Section 4 - That this Resolution shall become effective on the date of its passage.
