WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for municipal expenditures:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

-) \$ 1,258,520.00 from General Services District Fund to various accounts.
-) \$_618,000.00_ _to_Full Urban Services District Fund _from_ various accounts.
-) \$_43,640.14_ _to_ Refunding GO Bond 2015A _from_ various accounts.
-) $_43,640.14$ _ from _ 2017 Bond Projects Fund _to_ various accounts.
-) \$_193,846.50_ _from_ PFC Parks Projects Fund _to_ various accounts.
-) Re-appropriations within the General Services District Fund; General Fund Capital Projects Fund; Municipal Aid Program Fund; and the various Grant funds that do not result in changes to the Unappropriated Fund Balance of these funds.
- Section 2 That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0010" attached hereto and incorporated herein by reference.
- Section 3 That this Ordinance shall become effective on the date of its passage.

) Re-appropriations within the General Services District Fund; General Fund Capital Projects

Fund; Municipal Aid Program Fund; and the various grant funds that do not result in changes to the

Unappropriated Fund Balance of these funds.
