  - ) \$\_5,935.62 \_\_from\_ the Unappropriated Fund Balance in the Enhanced 911 Fund \_to\_ various accounts.
  - ) \$ 4,320.00 from the Unappropriated Fund Balance in the Central Kentucky 911 Fund to various accounts.
