SUBJECT: Amendment to Multi-Year Consolidated Plan and Annual Action Plan HOME

**Investment Partnerships Program Projects** 

**Request:** Council authorization to execute thirty-three (where 33 is the total number of documents) amendments to existing loan documentation, affecting multi-year Consolidated Plan/Annual Action Plan HOME Investment Partnerships Program projects to adopt the annual Utility Allowance established by Lexington-Fayette Housing Authority, where the final form of the amendments shall materially comply with the exemplar agreements, subject to the approval of the Department of Law and Grants and Special Programs, and further authorizing the mayor to execute any other agreements or amendments for multi-year Consolidated Plan/Annual Action Plan HOME Investment Partnerships Program Projects related to the use of these funds.

**Purpose of Request:** The U.S. Department of Housing and Urban Development HOME Investment Partnership Program requires participating jurisdictions to establish and update the utility allowance schedule annually. Currently per regulation the LFUCG uses the HUD Utility Schedule Model for certain HOME-assisted units. Since the regulations have changed, LFUCG would like to adopt the annual utility allowance established by the Lexington-Fayette Housing Authority for multi-year Consolidated Plan Annual/Action Plan HOME Investment Partnerships Program HOME-assisted projects.
