

**ADDENDUM NO. 3 TO EVALUATION SERVICES AGREEMENT WITH UNIVERSITY
OF KENTUCKY RESEARCH FOUNDATION**

THIS THIRD ADDENDUM TO AGREEMENT, made and entered into on this _____ day of _____ 2025, by and between **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, an urban county government pursuant to KRS Chapter 67A, and located at 200 East Main Street, Lexington, Fayette County, Kentucky 40507 (“LFUCG”), and **UNIVERSITY OF KENTUCKY RESEARCH FOUNDATION** (“UKRF”), whose main address is 109 Kinkead Hall, Lexington, Kentucky 40508;

WHEREAS, the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services and Administration (SAMHSA) awarded LFUCG grant funding over a period of four (4) years under the First Responders – Comprehensive Addiction and Recovery Support Service Grant (FR-CARA) in support of its Expanded First Responders and Community Partners Overdose Prevention Project (EFRCPOPP); and

WHEREAS, LFUCG and UKRF entered into an Agreement dated December 12, 2022 (“Agreement”), identifying UKRF as an “Evaluator” for evaluating processes and outcomes of the FR-CARA grant and oversight of reporting over the term of the grant period, compensating UKRF \$99,997.00 for their services;

WHEREAS, the Agreement states in part, in Paragraph 2 titled Effective Date; Term of the Statement of Agreement: “Upon mutual written agreement, the Parties may renew this Agreement, in whole or in part, for three (3) successive terms of one (1) year (each a ‘Renewal Term’), with the final Renewal Terms ending on September 29, 2026,”;

WHEREAS, the Agreement states in part, in Paragraph 5 titled Compensation; Method of Payment of the Statement of Agreement: “LFUCG shall compensate UKRF for the Services in an amount which shall not exceed Ninety-Nine Thousand Nine Hundred Ninety-Seven Dollars and 00/100 Cents (\$99,997.00) during each year of the Grant Period as outlined in Exhibit ‘B’ for the performance of the Services.”;

NOW, THEREFORE, in consideration of the foregoing and mutually agreed upon promises stated in the Agreement, the parties hereto agree to renew the Evaluation Services Agreement beginning September 30, 2025 through September 29, 2026 at an amount which shall not exceed Ninety-Nine Thousand Nine Hundred Ninety-Eight Dollars and 00/100 Cents (\$99,998.00).

The parties agree that all other terms and conditions of the Agreement dated December 12, 2022 shall continue to apply.
